- The bidders who had submitted the same Tender in the month of May 2022 (Previously) need to only upload the documents and need not submit hard copies of all the documents Again.
However if any new or additional documents are to be submitted then the same will have to submit in the hard copy to the Institute 05/07/2022/ 11.00 AM on any working day (except Saturday & Sunday)
- In the case of Joint Venture the eligibility in terms of experience or turnover will be the same as prescribed. Hence the experience or the turnover will be considered after the formation of Joint Venture of companies/ agencies.
- **Net worth Certificate to be included in the Documents.**

Points raised were as follows:

1. If the bidder had submitted previous tender for the same services published by the Institute in the month of May 2022, then should the bidder is required to re-submit all the documents again in the hard copy to the Institute?
- It was decided by the purchase committee and the Principal that the bidders need NOT submit the same documents again in hard copy. However if any new or additional documents the bidder wish to submit then only that to be submitted in hard copy.

However all the documents to be uploaded on the portal.

2. Bidder suggested that Net worth certificate should be taken from all the bidding parties as it will authenticate the turnover.
 - The purchase committee has agreed to the suggestion and a corrigendum will be uploaded regarding submission of Net worth Certificate.
3. Bidders asked for the clarification regarding any company/ agency which is in Joint Venture.
 - Purchase committee has agreed to allow the JV agency/ company, however the experience or turnover criteria will remain same as that of single entity.
The experience or turnover will be considered of the JV company.

The meeting was concluded at 4:00 pm and all the queries raised by the bidders were clarified.
